#### The Corporation of the Town of South Bruce Peninsula

#### By-Law Number 82-2023

#### Being a By-Law to Set Fees for the Services Performed by the Corporation of the Town of South Bruce Peninsula

Whereas Section 391 of the *Municipal Act, 2001*, as amended, provides that a municipality may pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it; for costs payable by it for services or activities provided or done by or on behalf of any other municipality or local board; and for the use of its property including property under its control;

And whereas Section 398 of the *Municipal Act, 2001*, as amended provides that fees and charges imposed by a municipality constitute a debt of the person to the municipality and that the Treasurer may add amounts owing to the tax roll;

And whereas Section 69 of the *Planning Act, 1990*, as may be amended from time to time provides that a municipality may pass a by-law establishing a tariff of fees with respect to planning applications;

**And whereas** the Council of the Corporation of the Town of South Bruce Peninsula establishes fees and charges by the enactment of a consolidated fee by-law.

# Now therefore the Council of the Corporation of the Town of South Bruce Peninsula enacts as follows:

- 1. That fees are outlined in the document attached hereto which forms part of this by-law.
- 2. That this by-law shall be known as the "Fee By-Law".
- 3. That it is intended that all provisions of this by-law shall be binding and effective. In the event that any particular provision or provisions or part of a provision is found to be void, violable or unenforceable for any reason whatever, then the particular provision or provisions or part of the provision shall be deemed severed from the remainder of this by-law and all other provisions shall remain in full force.
- 4. That non-payment of the fee on the due date specified therein shall result in a penalty of 2 percent being added and thereafter a penalty of 2 percent will be added on the last day of each month in which the default continues.
- 5. That in accordance with the *Municipal Act, 2001*, as may be amended from time to time, the Treasurer may add any uncollected fee or charge to the tax roll to be collected in like manner as taxes.

- 6. That on the first day of the commencement of each year, fees may be increased in proportion to the increase in the Consumer Price Index as published by Statistics Canada for the immediately preceding calendar year and that fee shall become the new base fee.
- 7. That the HST or other tax rates shall be the rate approved by the Government of Canada and/or the Province of Ontario as amended from time to time.
- 8. That this by-law supersedes any by-law or fee in any other by-law not consistent with this by-law.
- **9.** That the fees contained herein shall come into full force and effect on January 1, 2024.
