The applicant/owner will be fully and legally responsible for all costs associated with the application and any subsequent Encroachment Agreement, should the Town decide to enter into an Encroachment Agreement.

The application fee is non-refundable and all owners must sign this application. Applications which are missing signatures will not be considered.

The Town makes no guarantee regarding the length of time it will take to consider this application and make any decision.
