Every dog in the Town of South Bruce Peninsula must have a dog tag. To purchase a dog tag, please complete this form and return it to Town Hall with payment. If you are dropping off this form and payment outside of regular business hours or you are sending this form and payment by mail to the Town, you must include a self-addressed, stamped envelope so that the dog tag can be mailed to you.

**The fees for dog tags increase on June 1. The form must arrive at our office by May 31st for the discounted rate to apply. There are no exceptions.**

## Rules at a Glance-Dog Regulating By-Law (34-2019)

1. The Town of South Bruce Peninsula is a leashed municipality. No person shall allow a dog off the owner's property unless under control and leashed or in the "Dogs off Leash Recreation Area" (DOLRA).
2. No person shall keep more than the following number of dogs per location anywhere in the Town of South Bruce Peninsula:
  - In all areas of the municipality having a lot area of less than 0.4 ha (1acre) the maximum number of dogs permitted per household is two (2).
  - In all areas of the municipality having a lot area of equal to or more than 0.4 ha (1 acre) the maximum number of dogs permitted per household is three (3).
  - In all areas of the municipality having a multi dwelling unit the maximum number of dogs permitted per unit is two (2).
  - A household is permitted to have one visiting dog in addition to the maximum number of permitted dogs for no longer than a 48 hour stay, per week, providing that the dog is licensed and the licence is affixed to the dog's collar or harness. The property owner where the dog will be visiting shall provide 48 hours' notice to the Animal Control Officer and provide the property owner's address and contact information, the description of dog, the tag number and the dog owner's contact information.
3. Dogs are not permitted on Sauble Beach from June 1st to Labour Day in each and every year.
4. Dog licensing fees must be paid each year.
5. Kennels/boarding establishments are only permitted in areas which are appropriately zoned, in accordance with the Zoning By-Law.

Second Dog – per property/household January 1 - May 31	\$35.00
Second Dog – per property/household June 1- Dec 31	\$70.00
Third Dog – per property/household Jan 1 – May 31	\$45.00
Third Dog – per property/household June 1 – Dec 31	\$90.00
Kennel licenses, ownership changes, replacement tags, dangerous or potentially dangerous dog fees	As Per Fee By-Law

**NOTE: Dog tags expire on December 31 each year, regardless of when they are purchased in the particular year.**
