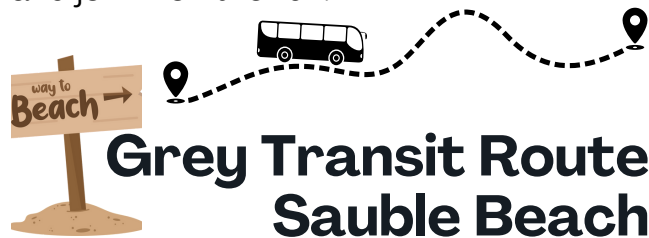

Emergency Planning

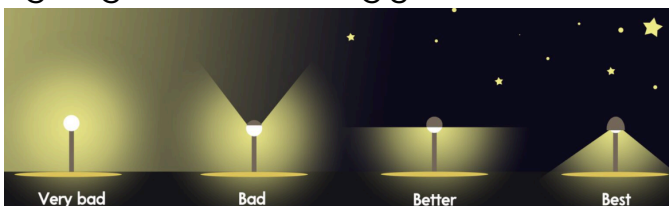
Don't wait for disaster to strike! Take these steps to ensure your household is ready:

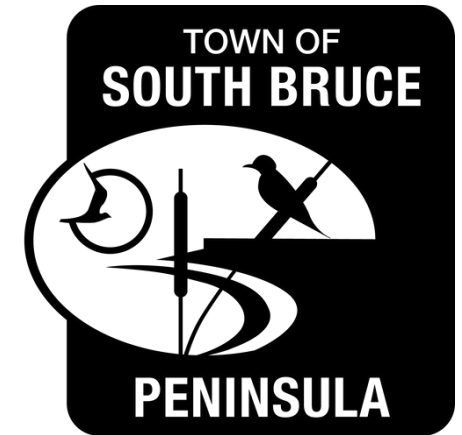
